# **Cookie Policy**

This Cookie Policy describes how Kanematsu Trading Corporationlocated at WORK VILLA KYOBASHI Bldg. 3F, 1-13-1,Kyobashi, Chuo-ku, Tokyo 104-0031, Japan ("our", "we" or "us") uses cookies and similar technologies to collect and store information when you visit our websites. For additional information on our privacy practices, please visit our <u>Privacy Policy</u>.

### What are Cookies?

Cookies are small text files that are stored on your computer, tablet or phone when you visit a website. We can collect information on your browsing activities such as how many times you visit our websites and what webpage you visit by using cookies. They are not executable codes nor are they spyware or viruses. Our websites, like most other websites, use cookies to enhance your experience on the web and to improve our sites.

#### What types of Cookies do we use?

Some cookies are deleted when you close down your browser. These are known as session cookies. Others remain on your device until they expire, or you delete them from your cache. These are known as persistent cookies and these types enable us to remember things about you as a returning visitor.

The main categories of cookies we use include:

- Strictly necessary cookies. Strictly necessary cookies are essential to enable you to receive a service on a website. For example, cookies to operate online shopping baskets, or to comply with the law (e.g. such as to keep your information safe). We would not be able to operate our website without using "strictly necessary" cookies.
- First and third party cookies. Whether a cookie is a first or third party cookie depends on which website the cookie comes from. First party cookies are those set by or on behalf of the website visited. All the other cookies are third party cookies. Please note that third parties (including, for example, advertising networks and providers of external services like web traffic analysis services) may also use cookies, over which we have no control. These cookies are likely to be analytical / performance cookies or targeting cookies.

# Why do we use Cookies?

We use cookies for the following purposes, amongst others:

- to help us to improve your experience of our websites;
- to ensure that our websites perform as you expect them to;
- to help us understand browsing habits on our websites;
- for internal record keeping;
- for product and service development;
- to answer your queries or complaints;
- to create statistical analysis of activity on our websites.

## How long will Cookies be stored?

Except for strictly necessary cookies, each cookie will expire after expiry period specified in the table in "Cookies used on our websites" section below.

#### Cookies used on our websites

The following table lists the cookies that we use on our websites.

Cookie Type	Description	Personal Data	Lifespan	Cookie Name
Functional / Security	Used by Google for authentication, session management, and ad personalization. Helps track user behavior on Google services.	No direct personal data, but can be used for tracking.	1 Year	AEC
Functional / Tracking	Stores user preferences and settings for Google services (e.g., language preferences, personalized ads).	No direct personal data, but used for personalization.	5 Months	NID

# How do you manage Cookie preferences?

The browsers of most computers, smartphones and other web-enabled devices are typically set up to accept cookies. If you wish to amend your cookie preferences for our websites, you can do this through your browser settings. Your browser's 'help' function will tell you how to do this. If you do not want the benefit of cookies, there is a simple procedure to manually delete your cookies.

However, please remember that cookies are often used to enable and improve certain functions on our websites. If you choose to switch certain cookies off, it is likely to affect how our websites work.
